In the AGM, the following agenda were discussed and decided by with the consent of all the Alumni present in the AGM:

1. Payment modality of the Regular Members:

The Regular Member will have two options for payment of Membership Subscription – (a) Life time payment and (b) Yearly payment.

The AGM approved on post-factor basis that the following Regular Members paid their membership subscription earlier on 'Life Time Payment' basis and as such they will not require to pay any yearly subscription:
