

Minutes of the Meeting Held on 19 Jan, 2024

The third meeting of the Executive Committee of the AITAA Bangladesh Chapter was held on 19 Jan, 2024 (Friday) at 3:30 pm at Dhanmondi, Dhaka. The meeting was presided over by the President of the association. The following members of the Executive Committee were present in the meeting:

Date and Venue of the Annual Picnic-2024 and EGM

It was informed in the meeting that a team of three members namely, Abul Kashem Md. Shirin (President), Dr Abdur Razzaque Akanda (General Secretary) and Prof. Dr. Kamal Uddin (Advisor) visited the Mamata Palli Resort at Zirabo, Ashulia recently and found the place as suitable for the picnic for the members and families of AITAA-B. Accordingly the Executive Committee decided to hold / organise the Annual Picnic-2024 and EGM at the Mamata Palli Resort, Zirabo, Dhaka on 17 February, 2024 (Saturday).

2. Program Schedule and Relevant Information:

5. Agenda to be placed in the EGM to be held on 17 February, 2024:

In the last AGM held in 2023, it was decided to arrange an EGM to change a few of the clauses of the Constitution/Statutes of the association. 6. Progress report of the Sub-committees

a) Membership Sub-Committee

The members of the Membership Sub-Committee informed that had enrolled a significant number of members in the WhatsApp group. Now they are trying to convert these WhatsApp members into the member of the Association. As of today, they have enrolled 312 members in the official WhatsApp group and on recommendation of the Membership Sub-Committee, the President has approved 102 new members of the AITAA-B and as such the total number of the association stands at 196.

The Executive Committee congratulates all the members of the Membership Sub-Committee for performing a great job.

b) Members Engagement Sub-Committee:

The Convener of the Members Engagement Sub-Committee informed that they had selected the venue for the upcoming Annual Picnic-2024 and EGM of the AITAA-B, and now working to make the Picnic and EGM a grand success. The Executive Committee conveyed thanks to the each of the members of the Engaement sub-committee for their hard work and wishes a grand success of the upcoming picnic and EGM.

c) Social Media and Website Sub-Committee

The Convener of the Social Media and Website Sub-Committee informed that they had updated the profile of the members of the association. Password of each of the members has been created and communicated to each of them through email. The members using this password can perform the login process and modify their particulars. A good number of new members are registered using the website of the Association. The Executive Committee conveyed thanks to the each of the members of the Social Media and Website Sub-Committee for their hard work.

7. Miscellaneous:

a) Fixation of subscription for different members:

The members present in the meeting discussed the socio-economic situation and come to a conclusion to fix the subscription as under:

i) Life member: One time subscription of Tk.30,000/- for the member at age 40 years and below; Tk.20,000/- for the member at age from 41 to 50 years; Tk.10,000/- for the member at the age above 60 years. This will be effective immediately after EGM (if the EGM approves this new category of membership).



ii) Regular Member: Tk.1,000/- for 2024; Tk.2,000/- from 2025 onward.

iii) Affiliate Member: Tk.1,000/- from 2024 onward.

b) Payment of shortfall amount USD 1024 to the AIT for renovation of a room of Dorm-F from the AITAA Bangladesh Chapter

The Member-Secretary informed that a total of Baht 2 lac was required to be donated to AIT for renovation of a room of Dorm-F. Taka 6 lac was handed over to the AIT Administration in the GBM which was held on 25 November, 2023 through our two delegates Prof Dr Kamal Uddin and Ms Tasnuva Ahmed. However due to fluctuation of conversion rate, there was a shortfall of USD 1024 only which needs to be sent to AIT as soon as possible.

The Executive Committee discussed the issue in detail, and agreed to pay USD 1024 to AIT soon.

There being no other agenda to discuss, the president concluded the meeting with vote of thank to everyone attended the meeting.
